StreamKeeper Progress

MVSK has supported stream bank vegetation restoration work in Old Mill Park and Boyle Park by the STRAW (Student and Teachers Restoring All Watersheds) program of the Bay Institute and the Bloomathon restoration of the Elizabeth Terwilliger Marsh banks. In addition in cooperation with local community agencies the following studies have been produced. They will be available at the Mill Valley Library October 25, 6-9 Creekside Room.

MVSK's work is far from done. We continue to actively seek grants, and donations, and to pursue other avenues to protect and restore our creeks and their watershed. Salmonid habitat restoration will continue to guide MVSK work – the steelhead that are in our creeks now, the coho that will be there one day in the future.

A Creek Depends on A Lot

Mill Valley's Municipal Code currently provides only minimum creek protection. The 30 foot setback is set forth in the Floodplain only. This does not protect the majority of our creeks, cascades, and intermittent streams. The Planning Dept. has scheduled a public hearing on a new basic creek protection ordinance **Nov. 14: Planning Commission & Nov. 21: City Council**.

The proposed ordinance continues the 30-foot setback from the top bank of the creek. A setback helps prevent bank erosion by providing an area where rainwater run-off and sediment can percolate into the soil before entering the creek. This cleaning and slowing effect can protect the quality of water in our creeks, having a positive impact on fish and other wildlife populations. In addition, the setback provides a buffer corridor for riparian wildlife, stormwater and native plants.

The proposed ordinance prohibits the construction, alteration, expansion, of any structure or impervious surface as well as placing fill, grading or paving materials within the 30-foot protection zone. Removal, destructtion or replacement of indigenous vegetation within this zone including the lateral branches of trees is also prohibited. The Coho Salmon are especially sensitive to warm water. Natural diversity is essential to stream health.

We urge the City and our readers to consider carefully this ordinance and to participate in the process of giving much needed attention and protection to our streams and our watershed. They are integral to the beauty of our town and to the integrity of our environment.

Creek Care* A Guide for Marin Residents Hint:

Limit pet access to the creek and keep pets on a leash. Pets scare off fish and wildlife and muddy the creek. Pick up after your pets. Animal waste increases bacterial levels and contributes excess nutrients to the creek.
