

2023 ACTIVITIES

LONG RANGE

>Supported Mill Valley's applying for a federal grant to remove/replace a bridge/culvert which creates a major barrier to Salmonid spawning in Old Mill Park. This request was refused, but there are plans to try again.

HABITAT RESTORATION

- >Organized two work parties to remove weeds and non-native plants from 1) the creek banks in a stretch of Old Mill Creek in Old Mill Park 2) an area at the foot of Cascade Dam.
- >Assisted with cleaning out owl boxes at the MV Golf Course
- >Removed broom plant from the Warner Creek channel at the Golf Course.
- >Continued effort to rid the streambanks of the invasive, non native sedge, Carex pendula.
- >Conferred on Monarch Butterfly Garden beside creek running by Mill Valley Lumber Yard.

EDUCATION & OUTREACH

- >Flew the MVSK banner over Blithedale Avenue during the week of Valentine's Day.
- >Upgraded and improved our Website with the generous financial and technical support of Mike Mooney, our newest board member.
- >Promoted and provided gloves, plants and tools to a 3rd to 8th grade science project of North Bridge Academy to replace non-native with native plants on creek bank between the Outdoor Art Club and Mill Valley Market.
- >Contributed money for scholarships for K 2 children from low income families to attend a total of 8 camper weeks at Marin Green Play Camp. They learned a lot about nature, to enjoy being in it, how to respect and care for it.

CIVIC OUTREACH

- >Had a table at Marin Earth Day, handing out information and discussing our work with the public.
- >Helped with problems of residents, including: clearing of a creek, building within five feet of a creek, boys playing in stream.

The Good and the Bad!

Some good:

>An otter swimming around in the stream.

We reported it to the otter-spotter-community-based-science group at https://riverotterecology.org and received thanks. If you should see otters in Mill Valley's creeks, please let us know!

>School Children involved in stream education and work.

North Bridge Academy, located in downtown Mill Valley, has begun the early stages of stream renovations to a section of the Arroyo Corte Madera del Presidio. 7th grade students have made several trips to the creek for general scouting, wildlife notes, camera trapping and the beginnings of invasive Carex removal. In 2024, this class and other grades from the school will visit the creek for continued non-native invasive removal, plantings of native riparian plants and surveys to restore the section of the creek as part of a unit on watersheds and in connection with raising rainbow trout in the classroom. With partnerships of the StreamKeepers, SPAWN and the Outdoor Art Club, North Bridge Academy looks forward to the progress of this exciting project in the new year!

>Opportunities for working together in the watershed coming up!

Some not good:

>Tires have a chemical which is death to salmons.

The chemical is shed from tires and washed into streams. The MV StreamKeepers hopes to get our streams tested next year. Hopefully we will have as small a level as was found in West Marin.

>Other pollutants get into the streams.

If an illicit discharge is discovered after hours or appears to be hazardous material, please contact the Fire Department 415-388-8182 or 415-389-4130

From CDFW:

To Report a Poacher or Polluter

If you witness a poaching or polluting incident or any fish and wildlife violation, or have information about such a violation, immediately dial the toll free CALTIP number **1 888 334-CALTIP** (888 334-2258), 24 hours a day, seven days a week.

Or you may submit anonymous tips to CDFW using **tip411**. **tip411** an internet based tool from

CitizenObserver.com that enables the public to text message an anonymous tip to wildlife officers and lets the officers respond back creating an anonymous two-way conversation. Anyone with a cell phone may send an anonymous tip to CDFW by texting "CALTIP", followed by a space and the message, to 847411 (tip411).
